1. This mare is booked by name and the booking is valid to this mare only. Neither booking nor the return privilege can be transferred without written permission from Braecrest Stables.
2. The mare's health condition is the responsibility of the Purchaser. The Purchaser will ensure that the mare is in sound breeding condition. It is recommended that the Purchaser's veterinarian examine and assess the mare's breeding soundness. The mare should have a negative uterine culture prior to breeding (but is not required). It is expected that the Purchaser follow the veterinarian's recommendation.
3. It is recommended that the Purchaser vaccinate the mare for Rhinopneumonitis (Equine Herpes Type 1) at 5, 7, and 9 months of pregnancy. The Purchaser shall also ensure that the mare is kept in proper condition and up to date on all worming and all other vaccinations.
4. It is strongly recommended that the above named mare be checked for pregnancy by uterine ultrasound by a veterinarian 14-17 days post breeding. The mare should be re-checked between 28-35 days for pregnancy. The Purchaser must inform Braecrest Stables of the above named mare's pregnancy status by day 55.
5. The full stud fee of \$1000 (includes \$300.00 non-refundable booking fee) plus HST where applicable, must be received before any semen will be shipped. Please make the payments via e-transfer, money order, or certified cheque.
6. The stallion stud fee includes the booking fee. The collection fees of \$270.00 per collection plus shipping fee will be charged for each collection. Payment is due prior to the shipment of semen. The first collection is included in the stud fee. If the collection must be done by a veterinary clinic, either due to the stallion's show schedule, or another reason, the Purchaser will be billed at the veterinary clinic's rate.
7. The semen will be shipped fresh cooled in a high quality disposable container. The cost for the container is \$40.00 per collection and does not need to be returned.
8. Braecrest Stables will charge the shipping cost via Federal Express to the Purchaser or the Purchaser's Federal Express account can be provided to cover these costs.

10. Braecrest Stables agrees to provide fresh cooled semen in viable condition from Braecrest Beaumont at the time of delivery to the Purchaser at the approved address. Braecrest Stables is not responsible for any semen shipments that are lost, delayed or damaged during transport. This semen must be administered by a licensed veterinarian or by a breeding technician (approved by Braecrest Stables) on the day of delivery, or the LFG and the contractual obligations may not apply.
11. The semen shipment from Braecrest Beaumont is to be used only on the mare named in this contract.
12. Semen can be collected Monday-Friday, as possible, March 1 -September 1, 2017. If the Purchaser requires semen before or after the normal season, Braecrest Stables will accommodate the Purchaser whenever possible. Weekend collections may be possible at added cost to the Purchaser. Please note that Federal Express does not do pickups on Saturday or Sunday. Whenever possible, mare owners will be accommodated. Because these shipments would have to be counter to counter (if possible), the Purchaser would be charged COD plus \$125.00 courier fee to the airport.
13. The Purchaser must contact Braecrest Stables 24 hours before semen shipment is required. For semen shipments placed after 24hour cut off, Braecrest Stables will accommodate the Purchaser whenever possible. We will try to fulfill them but cannot guarantee them, and they may be subject to a rush order fee. Semen orders will be filled in the order in which they are received. Although the standard semen shipment includes 2 doses, on busy peak days or on late orders, one dose of semen may be shipped.

14. The Purchaser understands that the stallion may be competing during the breeding season and will not always be available for collection. It is the Purchaser's responsibility to contact the farm for dates the stallion will be available for collection. Braecrest Stables will make every attempt to publish the stallion's show schedule to Purchasers well in advance.

15. The Purchaser assumes all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whatsoever by death, disease, injury, infection or otherwise, and by any cause whatsoever, including inappropriate, untimely, or negligent insemination or failure of insemination and therefore releases, discharges, indemnifies and holds harmless Braecrest Stables, its owners, its employees and agents from any and all damages associated therewith.

16. The Purchaser agrees that no embryo transplants from the above named mare using semen from Braecrest Beaumont are to be done without the prior written permission of Braecrest Stables.

17. If the mare fails to conceive during the 2017 season, the Purchaser is entitled to a return breeding the following three (3) years. Please inform Braecrest Stables by no later than October 15, 2017 as to whether or not the mare is in foal. A veterinary certificate is required. This report must be sent to Braecrest Stables for the Live Foal Guarantee and the return breeding to be honored. It will be the Purchaser's responsibility to pay the booking fee, the new season's collection, transportation and deposit fees.

18. Live Foal Guarantee: If the mare, after being checked in foal, aborts or does not produce a live foal that can stand and nurse on its own and survive 7 days after birth, the Purchaser is entitled to a return breeding in the following three years (2018, 2019, 2020). It will be the Purchaser's responsibility to pay the booking fee, the new season's collection, transportation and deposit fees. A veterinary certificate is required within five (5) days from the date of death and/or examination. Otherwise, the LFG is null and void.

19. No paper work shall be issued to the Purchaser until all fees have been paid.

20. A certificate of service will be issued to the Purchaser once all fees have been paid in full, and once the stallion owner receives notification of the birth of the foal.

21. Interest will be charged at a rate of 3.0 % monthly on all balances owing after 30 days.

22. This contract shall not be transferred.

23. The laws of the Province of Ontario, Canada shall govern the terms of this agreement.
