BREEDING FEE AND LIVE FOAL GUARANTEE (LFG)

Breeding Fee: \$1,800.00 CAD (+HST for Canadian clients)

Booking Fee: \$400.00 CAD (+HST for Canadian clients) due at contract signing. This includes the first collection but not shipping or container fees.

Balance Due: \$1,400.00 CAD (+HST for Canadian clients) due in full before first collection of fresh semen.

If the mare is not in foal and the owner wishes to try again in 2027, a new booking fee is required.

Please note, the mare is booked by name, and the booking is valid for this mare only. Neither the booking nor return privilege is transferable without written permission from the stallion owner.

MARE HEALTH REQUIREMENTS

The mare owner is responsible for ensuring that the mare is in sound breeding condition.

- A vet should assess the mare's breeding soundness, and a negative uterine culture is recommended prior to breeding.
- Pregnancy should be confirmed by ultrasound 14-17 days post-breeding.

If the mare is not found in foal after two shipments, it is highly recommended that the mare be swabbed before further breeding attempts.

COLLECTION & SHIPPING FEES

- The booking fee includes the first collection only. It does not include shipping or container fees.
- Additional collections: \$300.00 CAD (+HST) per collection, payable before shipment.
- Shipping & Container Fees: Purchaser is responsible for all shipping and container costs.
- The semen is to be used for the mare named in this contract only. Any additional foals produced from the breeding must pay an additional \$1800.00 CAD (+HST) breeding fee per foal to receive a breeding certificate to register the foal(s).
- It is highly recommended the Purchaser has a Fedex Account # for simplifying the shipping process

Braecrest Stables agrees to provide fresh, cooled semen from **Caballero Dwerse Hagen Z** in viable condition at the time of collection to the shipping address provided on the Semen Request Form. The stallion owner is not responsible for semen shipments lost, delayed, or damaged during transport. The semen must be administered by a licensed veterinarian or by a breeding technician approved by Braecrest Stables on the day of delivery or the LFG, and the contractual obligations may not apply. The Purchaser assumes all responsibility for the condition of the mare and shall bear all risk of loss or damage to the mare whatsoever by death, disease, injury, infection, or otherwise, and by any cause whatever, including inappropriate, untimely, or negligent insemination or failure of insemination and therefore releases, discharges, indemnifies and hold harmless Braecrest Stables and its owners, its employees and agents from any and all damages associated therewith.

If the mare fails to conceive during the 2026 season, the Purchaser can use the breeding in the following two (2027 & 2028) seasons. The purchaser must inform Braecrest Stables if the mare is in foal no later than September 15th, 2026. This information must be sent to Braecrest Stables so that the Live Foal Guarantee (LFG) and return breeding will be honoured. It will be the Purchaser's responsibility to pay the new season's booking (incl. first collection) of \$400.00 CAD (+HST for Canadian clients), additional collections (if applicable), shipping, and container fees.

LIVE FOAL GUARANTEE (LFG)

A "live foal" is defined as one that stands, nurses, and survives for 30 days. If the mare aborts or fails to produce a live foal:

- The Purchaser is entitled to a return breeding in the following two breeding seasons (2027 & 2028).
- A new booking fee and associated costs apply.
- A veterinary certificate is required within five (5) days of the foal's death or examination.
- Braecrest Stables does not offer LFG for embryo transfer.

If the stallion dies or cannot produce viable semen, frozen semen from the stallion (only if available) will be provided. The maximum time limit on this contract is two (2) years.

ON-FARM BREEDING REQUIREMENTS

If your mare will be coming to Braecrest Farm for on-farm breeding, the mare owner is required to provide a negative cervical culture, negative Coggins test, and proof of vaccinations before or upon arrival.

Daily mare care fees:

- \$35.00 CAD + HST per day (mare only)
- \$50.00 CAD + HST per day (mare with foal)
- All veterinary expenses are billed directly to the mare owner.

GENERAL TERMS

This contract shall be binding upon both parties, when accepted by the Purchaser. This contract is transferable only with written permission from the stallion agent/owner.
